- 20 A. Upon entry of the decree of adoption, the relationship of parent and child and  
21 all the legal rights, privileges, duties, obligations and other legal consequences of  
22 the natural relationship of child and parent shall thereafter exist between the  
23 adopted person and the adoptive petitioner in lawful wedlock. The adopted child  
24 shall be entitled to inherit real and personal property from and through the  
25 adopted child the same as though the child were born to the adoptive petitioner in  
lawful wedlock.  
B. Upon entry of the decree of adoption, the relationship of parent and child  
between the adoptive person and the persons who were his parents just prior to the  
decree of adoption shall be completely severed and all the legal rights, privileges,  
duties, obligations and other legal consequences of the relationship shall cease to  
exist, including the right of inheritance, except that where the adoption is by the

1 spouse of the child's parent, the relationship of the child to such parent shall  
2 remain unchanged by the decree of adoption.

3 The natural father expressly waives any notice of any further adoption and severance  
4 proceedings and he hereby joins in said petition and respectfully requests that the prayer thereof  
5 be granted.
